Chautauqua Opportunities, Inc. (COI) is the lead agency for the Homeless Management Information System (HMIS) project and is requesting renewal funding to maintain the system required by the Department of Housing and Urban Development (HUD). The geographic area served by the HMIS is Chautauqua County, New York, which is located in the southwest corner of the state. Chautauqua County has a population of 134,905 (2010 Census) and is primarily rural with the two small Cities of Jamestown and Dunkirk located at either end. Chautauqua County's HMIS utilizes Mediware software (previously named Bowman Systems' ServicePoint). It is a web-based software system designed to meet HUD's technical requirements for data and information security and integrity. COI is seeking a renewal grant of \$20,976. Bowman Systems' costs include annual license renewal costs (which includes one free license for each Homeless Coalition member agency). Funding is also requested to support the salaries of a Data Support Specialist (.2 FTE) to run annual and data quality reports and a Quality Assurance Coordinator (.15 FTE) to provide training and technical assistance to all member agencies. The budget also includes rent and utilities, supplies, postage, training, janitorial costs, phone, and liability insurance. Administrative costs of 10% of direct costs are also included.
