3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Dunkirk Housing Authority is requesting funding to provide scattered site units in Chautauqua County for homeless with severe and persistent mental illness. Support services will be provided by Southern Tier Environments for Living, Inc (STEL). This is a Housing First Model. The population served in this Shelter Plus Care program are homeless persons who have a history of serious and persistent mental illness. Many have histories that include chemical addiction, legal involvement, frequent inpatient hospitalizations, and unstable and/or dysfunctional living situations. Many of the individuals have experienced difficulty in maintaining their safety, putting themselves in high-risk positions to be victimized by people in the community. Most of the population is on medication, with the majority needing some monitoring of these medications. Many have poor physical health related in part to their diet, lifestyle and side effects from medications. Budgeting and money management challenges are other areas in which many of these consumers struggle. This population often tends to be disconnected or removed from family and friendships can often be limited. The majority of the individuals are not working and most have limited work histories. The assistance provided to the target population is delivered within a Psychiatric Rehabilitation model based on goal setting and skill development in conjunction with ensuring a safe and manageable living environment. Program staff assists participants in developing individualized support plans, which help participants attain self-sufficiency. Plans may include training to gain independence in tasks such as shopping, getting to treatment appointments, medication management, daily living skills, and accessing affordable transportation. Program staff coordinates community linkages to be utilized by the individual to maintain psychiatric stability, reduce substance abuse, increase self-sufficiency and maintain housing. Program staff provides immediate response to psychiatric and behavioral emergencies, assisting the individuals in securing the appropriate level of intervention. Without these supportive services, many of the individuals currently being served would not manage their lives at the level of independence afforded by the Shelter Plus Care program. The chronically homeless will be given priority for PSH beds as vacancies become available through turnover.
