This HUD SHP grant is set up to pay 100% of rent and estimates that the participant has no income. Homeless participants had more income and therefore could pay a portion of the rent. Therefore the grant was under spent and funds were returned to HUD.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This project provides funding for 12 scattered site units in Chautauqua County for homeless individuals with severe and persistent mental illness. The homeless individuals are either coming from the streets, emergency shelters for the homeless or places unfit for human habitation. These homeless individuals may either be accompanied, i.e. family with or without children, or unaccompanied. These homeless individuals may also have a dual diagnosis of substance abuse. These homeless individuals due to their illness are vulnerable and easily victimized. Due to being homeless these individuals may have also lost their income and benefits. These individuals are in need of permanent housing and the support services to transition into permanent housing and to maintain their housing. Housing services include a leased apartment, which is in the agency name, and is fully furnished. Support services provided include housing placement, accessing benefits and income, re-engagement with treatment services and working on individual goals in the individual service plan. When the individual has a roof over their head their stressors are reduced and this allows them to be able to work on their recovery which reduces their need for high end services such as hospitalizations and emergency room visits. Other support services include a bus pass for transportation needs and working with the individual on goals such as employment, volunteering or education if the client so chooses. Goals are person centered and are based on the client’s needs and aspirations. Throughout the process the client is an active participant while in the program and they are offered choice on where they want to live, they pick out their furniture and household items and choose the goals they want to attain in their individualized services plan. The chronically homeless will be given priority for PSH beds as vacancies become available through turnover.
