Child Care Keeps Chautauqua County Working



DECEMBER IS SAFE TOYS AND GIFTS AWARENESS MONTH.

This month is all about raising awareness of safe toys and gifts for children. Every year, thousands of children are injured by unsafe toys and gifts.



You can ensure the safety of the children in your care, by doing your research, paying attention to age recommendations, and inspecting toys before you buy them. If you have any concerns about a toy, you can always check the Consumer Product Safety Commission Recall website.

Here are some more helpful tips regarding safe toys:

Be aware of safety recalls.

Supervise children when they are playing with toys.

Inspect toys for any broken pieces or parts prior to children playing with them.

Follow age recommendations on toys, especially for infants and toddlers.

Maintain sanitary standards for cleaning toys, especially toys that young children put in their mouths.

Regulations Review

MATERIALS & PLAY EQUIPMENT

GFDC 416.5(n)(1-5) FDC 417.5(n)(1-5)

- (1) Materials and play equipment used by the children must be sturdy and free from rough edges and sharp corners.
- (2) Play equipment must be in good repair, and be placed in a safe location.
- (3) Play equipment must be used in a safe manner.
- (4) Play equipment must be used specifically for its intended purpose. Such equipment and apparatus may be used only by the children for whom it is developmentally appropriate.
- (5) There must be a cushioned surface under all outside play equipment that present a fall hazard. Surfacing may not include concrete, asphalt, grass or hard compacted dirt.



SACC 414.5(n)(1-5) DCC 418-1.5(n)(1-5)

- (1) Materials and play equipment used by the children must be sturdy and free from rough edges and sharp corners.
- (2) Play equipment must be installed and used in accordance with the manufacturer's specifications and instructions, be in good repair, and be placed in a safe location.
- (3) Play equipment must be used in a safe manner.
- (4) Play equipment and apparatus may be used only by the children for whom it is developmentally appropriate.
- (5) All programs that substantially modify, or install new, outside play equipment must do so in accordance with the U.S. Consumer Product Safety Commission's Public Playground Safety Handbook.

Three Questions to Close the Year with Joy.

What drained me the most, and what did it teach me about what I need? Joy doesn't ignore the hard parts. It learns from them. This question helps you name the conditions that make your work heavier and the boundaries or supports you may need next year.

What was one moment this year when I felt fully alive in my work? Think of a moment when you felt present, purposeful, or proud. These moments tell you something about what energizes you

What is one practice I want to protect, start, or return to in 2026 that will nurture my joy? This might be a morning ritual, a moment of quiet before greeting children, a commitment to ask for help, or an intentional pause before responding during stressful moments.

Why This Matters

When we reflect on what fuels us and what drains us, we create a more humane foundation for the work ahead. Joy in the Work isn't a feeling, it's a practice. And this practice helps you stay aligned with your purpose, connected to your strengths, and grounded in what matters most.

Take a few minutes this month to reflect on these questions. You deserve to greet the new year not just with plans and goals, but with clarity, steadiness, and a sense of joy that's rooted in who you are and how you want to show up for the children and families you serve.

The Quality Care Materials Grant for child care providers is to purchase materials that directly enhance the quality of care in their programs. This may include educational toys, sensory materials, classroom furnishing, or professional resources that support developmentally appropriate practices. The goal is to strengthen learning environments and promote high standards of care across early childhood settings.

We recognize that many providers face challenges in meeting the diverse developmental needs of children due to limited resources and specialized training. In response, we are launching a shared services model in Chautauqua County that equips early childhood providers with hands-on, developmentally appropriate strategies and materials tailored to your program and the individual needs of the children you serve.

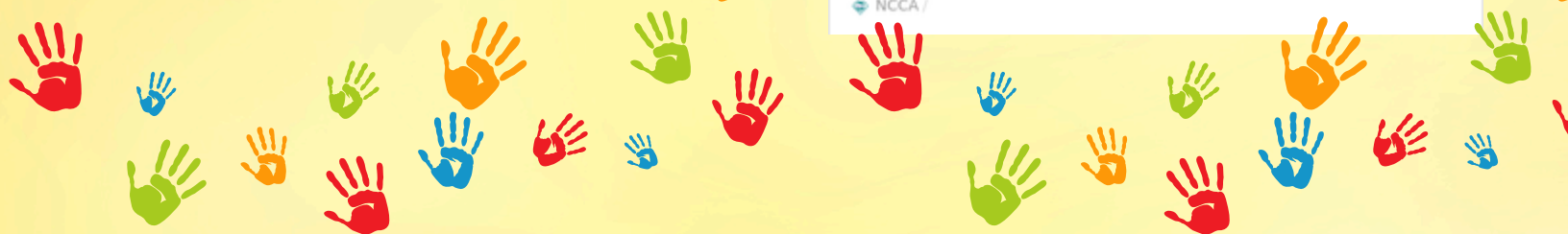
