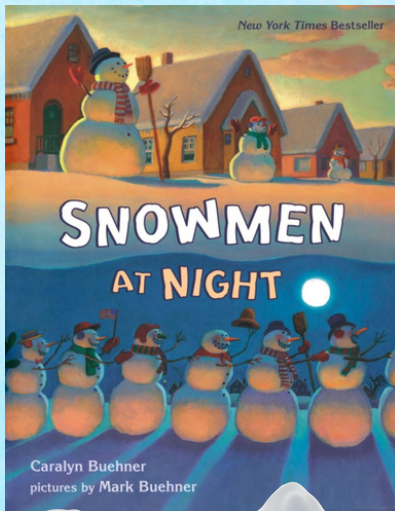
Winter Wonderland

Regulations Review Behavior Management

FDC 417.9 (a-d) GFDC 416.9 (a-d)

- (a) The family day care registrant must establish and follow a written plan for behavior management that is acceptable to the Office. This plan must include how the program will approach challenging behaviors, help children solve problems, and encourage acceptable behaviors.**
- (b) The caregivers must use acceptable techniques and approaches to help children solve problems.**
- (c) The program must provide copies of the behavior management plan to all caregivers and parents.**
- (d) Discipline must promote positive self-esteem in children and guide children in such a way as to help each child develop self-control and assume responsibility for his or her actions through clear and consistent rules and limits appropriate to the ages and development of the children in care.**

DCC 418-1.9 (a-d) SACC 414.9 (a-d)

- (a) The program must establish and follow a written plan for behavior management that is acceptable to the office. This plan must include how the staff will approach challenging behaviors, help children solve problems and encourage acceptable behaviors.**
- (b) The staff must use acceptable techniques and approaches to help children solve problems.**
- (c) The program must provide copies of the behavior management plan to all staff and parents of children in care at the program.**
- (d) Behavior management must promote self-esteem in children and guide children in such a way as to help each child develop self-control and assume responsibility for his or her actions through clear and consistent rules and limits appropriate to the ages and development of the children in care.**

- Infant and Early Childhood Mental Health Consultation to focus on social emotional development and educator well-being

Early Childhood Nutrition Improvement Act and the Child Care Nutrition Enhancement Act

The Early Childhood Nutrition Improvement Act which includes:

- Allowing providers who are open for more than 8 hours in a day to be reimbursed for an additional meal (up to 3 meals and 1 snack).
- Aligning the calculation of reimbursement rates for family child care homes with that of centers by shifting to “food away from home.”

The Child Care Nutrition Enhancement Act which includes:

- increasing reimbursement rates by 10 cents for all CACFP providers
- Eliminating tiering of family day care homes – all homes would receive tier I rates (no need to qualify by school, census, etc.)

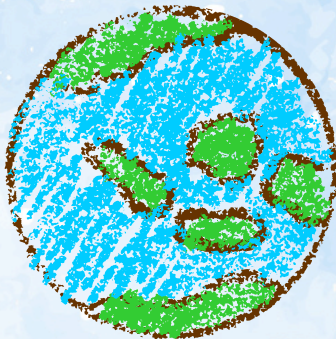
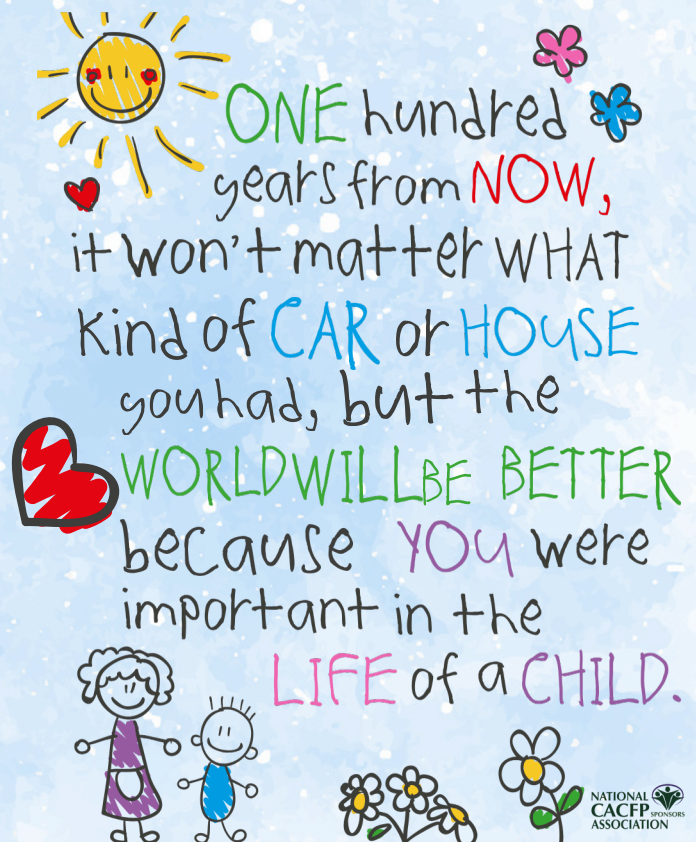

Healthy Spaces Safe Places Grant

The Healthy Spaces, Safe Places grant for child care providers is to improve health and safety within their programs. Grant funds can be used for items such as first aid supplies, safety equipment, or health-related training.

This grant helps ensure that all children thrive in environments that are both safe and supportive.



Quality Care Materials Grant

The Quality Care Materials Grant for child care providers is to purchase materials that directly enhance the quality of care in their programs. This may include educational toys, sensory materials, classroom furnishing, or professional resources that support developmentally appropriate practices. The goal is to strengthen learning environments and promote high standards of care across early childhood settings.

Caring Beyond Limits Grant

We recognize that many providers face challenges in meeting the diverse developmental needs of children due to limited resources and specialized training.

In response, we are launching a shared services model in Chautauqua County that equips early childhood providers with hands-on, developmentally appropriate strategies and materials tailored to your program and the individual needs of the children you serve.
